Shortly after the CLIMBER Loan program started, staff noticed no traction for the program. Feedback from the lending institutions said it was because businesses did not qualify. This is when they launched the outreach program with APEX and started engaging with six different outreach organizations. The program did not see a lot of return from the outreach and the money that was utilized has just been sitting there. The staff is proposing to take the remaining 98,000 dollars approved for community outreach and give staff the discretion to find and use it for some sponsorship opportunities as they arise. Each sponsorship would be 2,500 dollars, and Dave would have final approval, so the Board and Staff are not doing the same things.
