Program Administrative Rules

- Working with CO Secure Staff provided feedback in advance of May 31 deadline
- Ensuring rules are consistent with program/operational processes

Investment Selection

- Vestwell/BNYM will need a minimum of 60 days to set up all operational components once the program investments are selected
- Targeting early August identification for October pilot launch

Confirming Program Design Elements

• Working with state to confirm preferred design/program elements – will be utilized for development of Saver/Employer portals, program website, etc.

Finalize branding – begin development of website "landing page" and then full program site and saver/employer portals

- Set launch schedule for 2023 specifically thinking through employer deadlines and notification schedule
- **1**Sign contract with CO, prepare for any partner agreements
- Begin development of program documents EE and ER fact sheets, program description, employer and saver notices, etc.
- Continued regular meetings with CO staff for pilot engagement, program development, communications/marketing, etc.
