  - Pay for dependents on the health insurance plan at time of death
- Head of the Dept, or designee. add title

- Hyperlink the board policies on the application
- Confirm that the application is on Treasury's website
- Prop 130 Fund
  - Governor's office is working on it, including stakeholders, trying to get more detail. Stan doesn't think there's a connection, unless we want there to be. There will most likely be a bill this year to determine more details. Is there an opportunity to include CBB in a portion of the death benefit, ex: the interest earned on the fund? Stan will float the idea with his network.
  - Kevin makes a note that whoever determines the definition of line of duty might need more detailed criteria. Stan agrees, but definition should be the same.
  - Dave makes a note that interest going back in the fund.
     Suggest a definition of dependents. Makes a note that additional duties would require more staff.
