Mission is to have the employers and staff to have a good experience. Staff has learned the following from other States.

- 1. Deadlines should be established way before enforcement.
- 2. Notify employers multiple times before and after the registration deadline
- 3. Peak registration will happen during the weeks before and after the deadline.
- 4. Enforcement agency is CDLE and they will send the noncompliance notices.

Waiting on employment data to decide how they will be dividing the business rollout. Also to see how many employers fit into the Grant program.

Vestwell explained opt out exemptions for employers.
